We have a group under the European Union of Phoniatrians (UEP): the Biomarker Committee.

A project is suggested of a book where we convert our webinar presentations into a book titled 'Voice Biomarkers'. The 5 members of the subcommittees are listed above.

The plan is a webinar every second month with a main presentation, where three have been made and two are planned. We suggest that articles are made from the presentations, in a co-work between the presenters and the committee group. It is our experience that in recent years many engineers are using fully fledged software for analysis of voice, even if the analyses have been made in running speech sequences without defining voice features, and without specification of the choice of machine learning programs.

The idea is to work closely with the presenters to edit the webinar presentations.

One of the main topics of our group will be to define which features are usable as biomarkers in patient care.

The title of the first presentation was: Mieke Moerman. Voice in Biomarkers. Introduction.

Webinar in the Biomarkers Committee, 21st of Jun. 2023.

The title of the second presentation was: Mette Pedersen, Vitus Girelli Meiner. Overview of Voice Parameters in Parkinson's Disease eventually usable as biomarkers.

Webinar in the Biomarkers Committee, 6th of Sep. 2023.

The title of the third presentation was: Alberto Paderno. AI-enhanced voice analysis for neurologic diseases. Webinar in the Biomarkers Committee, 7th of Nov. 2023.

The book will fill in a very much needed description of voice as a biomarker. The current situation is problematic because engineers use sentences for voice analysis without describing or understanding voice as a separate defined parameters among others visually. Treatment effect of voice disorders cannot be made in the way that engineers define features of speech measurements. Clinical studies in our group will solve this problem.
